### 1. Introduction

Sexting has been defined as "the exchange of sexual material via a technological device" (Van Ouytsel et al., 2015, p. 1) or, more specifically, as "sending and receiving sexually explicit messages, or nude or semi-nude photographs or videos electronically, primarily between cell phones, but can occur between any media-sharing device or technology" (e.g., email, social media) (Katzman, 2010, p. 1). Definitions of sexting may vary based on the behaviour in question and the type of material exchanged (Barrense-Dias et al., 2017). For example, sexting behaviours may be distinguished by sending one's own sexually explicit images (Marume et al., 2018) or non-consensual dissemination of sexual content via third parties (Villacampa, 2017); the former being categorized as primary sexting and the latter as secondary sexting (Schmitz & Siry, 2011).

A 2018 report on the sexting behaviours and attitudes of a sample of 800 Canadian youth between the ages of 16 and 20 years reported that 35% of boys and 40% of girls had ever sent a solicited sext, and 20% of boys and 18% of girls had ever sent an unsolicited sext (Johnson et al., 2018). Sending and receiving sexually suggestive messages is more prevalent than sexually suggestive images (Katzman, 2010). The prevalence of sexting is reportedly on the rise in youth, likely due in part to the rise in rates of smartphone ownership (Mori et al., 2019). Social distancing mandates during the COVID-19 pandemic have given greater reason for individuals to engage in online sexual behaviours, such as sexting (Lehmiller et al., 2020). A team of researchers from the Kinsey Institute reported that during lockdown orders, more adults 18 years of age or older sexted, had cybersex with someone (i.e., instant messages or video), had phone sex with someone, and/or watched pornography online (Lehmiller et al., 2020). While no specific research on adolescent sexual behaviour during the COVID-19 pandemic has been published to date, it is possible that similar behaviour changes are occurring among this group.

Sexting is a relatively new phenomenon and was practically non-existent within the PubMed research literature 10 to 15 years ago (Katzman, 2010). However, due to the potential consequences of sexting, the phenomenon has gained increased public and scientific attention (Gewirtz-Meydan et al., 2018). There is some debate within the scientific community regarding whether sexting is a normative form of sexual expression (Döring, 2014; Villacampa, 2017) or a risky behaviour (de Souza & Alves Banaco, 2018). When consensual and between people of the legal age of consent, engagement in sexting can be a low-risk (i.e., no risk of sexually transmitted infections and/or unintended pregnancy), enjoyable, intimate behaviour (Dir et al., 2013). Other potential positive consequences of sexting can include sexual arousal and enhancements to a romantic relationship (Hudson & Marshall, 2017). Sexting can be part of healthy sexual exploration and relationship-building, particularly for older youth and adults (Mori et al., 2019).

The available research literature on the impacts of sexting in youth is mixed, with some research studies finding associations between sexting and risky sexual behaviours and mental health issues, and others not finding these associations. This may be due in part to the considerable variability in how sexting is defined and measured across studies. Kosenko et al.'s (2017) meta-analysis of 15

articles found associations between sexting, sexual activity, unprotected sex, and number of sexual partners, although the associations were weak to moderate. Mori et al.'s (2019) more recent meta-analytic synthesis of 23 studies with youth found associations between sexting, increased substance use, higher experiences of anxiety and depression, increased engagement in sexual activity, having multiple sexual partners, and lacking contraception use. However, many of these associations were weaker in older adolescents, suggesting that younger adolescents may be more susceptible to the risks associated with sexting. These authors suggest that younger adolescents may be less equipped to handle the social and physical implications of sexting, and may be more vulnerable to online dangers such as sextortion (i.e., being blackmailed to send nude photos, or money to avoid having photos shared). They also suggest that sexting at a young age, like sexual activity at a young age, may cluster with other risky behaviours.

Negative outcomes related to sexting may be more likely if a sexting conversation and/or explicit images are shared with others without consent (i.e., other than whom they were originally intended). In non-consensual situations, or in situations where one or more individuals is under the legal age of consent, various emotional, social, and legal consequences can arise (Choi et al., 2016; Dekker & Thula, 2017; Klettke et al., 2014; Livingstone & Görzig, 2014). An obvious concern with sexting is that the material can be easily and widely shared (Katzman, 2010). If sexts are shared non-consensually (secondary sexting), there may be a risk for online aggression or victimization (e.g., cyberbullying, online dating violence, revenge porn) (Bates, 2017; Drouin et al., 2015; Fahy et al., 2016; Klettke et al., 2014), which can also lead to negative emotional impacts (Slonje et al., 2017). Resulting social consequences may involve the experience of insults, humiliation, and damaged reputations (Katzman, 2010; Wood et al., 2015).

Medrano et al. (2018) found that sexting can make youth more vulnerable to cyberbullying, which in turn can lead to depressive symptoms (e.g., isolation and feeling ashamed, sad, or desperate). These symptoms may worsen and lead to suicidal ideation. However, these authors also suggest that suicidal ideation may be present to a lesser extent when sexting first begins, since both are risk behaviours among youth. The emotional and social impacts of secondary sexting can differentially impact individuals based on gender, where girls have been found to experience more negative impacts compared to boys (Betts et al., 2019). Compared to girls, boys are more likely to experience positive consequences such as peer group acceptance (Burén & Lunde, 2018).

Legal consequences related to sexting generally include charges related to the distribution of child pornography (Katzman, 2010), depending on regional laws and interpretations of the content and age(s) of individuals involved (Patchin & Hinduja, 2019). For example, an 18-year-old may be charged and become a registered sex offender for sharing explicit images of a 16-year-old with their friends (Patchin & Hinduja, 2020). In 2001, the Supreme Court of Canada decided that young people have the right to express themselves sexually through the creation and sharing of sexual images of themselves if the image is created and sent voluntarily between consenting individuals close in age; the image does not depict abuse or assault; and the image remains private and is not posted or shared (R. v. Sharpe, 2001). Sharing sexual images and video without consent can be prosecuted

under the Criminal Code of Canada. Due to the potential negative outcomes from sexting, educational efforts "to raise awareness of digital health, safety, and security are needed to help youth navigate their personal, social, and sexual development in a technological world" (Mori et al., 2019, p.770). There is some debate regarding the educational approach to adopt when teaching about sexting. Some scholars, educators, and policymakers believe that abstinence approaches are appropriate so that individuals can avoid any potential risks related to sexting, while others believe that a harm-reduction approach that aims to minimize risk while engaging in sexting is most helpful (Johnson et al., 2018). Generally, abstinence-only approaches to sexting and fear-based messaging regarding risks are not effective for decreasing engagement in the behaviour or reducing potential harms (McEllrath, 2014; Strohmaier et al., 2014; Patchin & Hunduja, 2019). As an alternative, many researchers recommend more comprehensive, harm-reduction approaches to education that teach individuals to make informed decisions about their intimate lives (Jørgensen et al., 2019; Patchin & Hinduja, 2019).

#### 1.1 Current Report

The purpose of the current environmental scan was to gather current, evidence-based resources focused on sexting and its impacts on youth sexual and reproductive health decision-making and mental health. Resources were considered "current" if they were published and/or updated within the last 10 years. Evidence-based resources were identified by their inclusion of citations and/or reference lists and/or by the reputation of the organization. The identified resources (e.g., website content, downloadable brochures and fact sheets, guides, videos) are organized into three main sections in this document: parent/guardian resources, youth resources, and educator resources. Resources within each section have been separated by region, when available: Canada, the United Kingdom, Australia, the United States of America, and parts of Europe.

The information gathered through this environmental scan may be helpful to parents/guardians, youth, and educators seeking materials to educate themselves or the youth in their lives about sexting. Potential gaps in existing materials may also be identified with this scan. This information is important to the work of the Saskatchewan Prevention Institute, a non-profit organization whose mandate is to promote child health and well-being and to reduce the occurrence of disabling conditions in children through primary prevention and education efforts. The Saskatchewan Prevention Institute's Sexual and Reproductive Health Program aims to help individuals make informed decisions and healthy choices through the provision of evidence-based education and resources. Identifying available online national and international resources related to sexting will help guide education efforts in this area, including any potential development of new resources and website content on <a href="https://www.skprevention.ca">www.skprevention.ca</a>.

### 2. Method

The current environmental scan consisted of an online search, using keywords that were entered into Google in various combinations (e.g., sexting, sharing images online, resources, lesson plans, teaching guides, youth, adolescent, teen/teenager, parents, guardians, educators, teachers, Canada, United Kingdom, Australia, American/United States of America) on three different dates: September 24, September 29, and October 2, 2020. When a potentially relevant resource or organization was identified on another organization's website, the website of this organization was then searched to obtain any relevant information. Given an online search method was used for the current environmental scan, it is important to note that there are likely many resources developed and used by organizations that are not included because they are not available online.

Resources related to sexting were included if they:

- appeared on organizations' websites
- appeared to be current (i.e., developed or updated within the last 10 years)
- were evidenced-based (i.e., included citations/references or came from a reputable organization)
- offered a distinct approach to addressing the phenomenon of sexting (e.g., how-to guides, youth perspectives, etc.)
- could inform the development of future resources and website content for the Saskatchewan Prevention Institute
- focused on the impacts of sexting on youth sexual and reproductive health decision-making and/or mental health

Using the information gathered through this scan, Resource Tables were created to summarize the available online national and international materials related to sexting for parents/guardians, youth, and educators (see Appendices A, B, and C, respectively). These tables include the organization's name, website, title of the resource(s), links to the resource(s), indication of the type of resource(s), brief summary of the resource(s)' content, and indication of the use of citations/references within the resource(s).

# 3. Summary of Findings

A total of 140 distinct resources on sexting are included in this report, including a variety from Canada, the United Kingdom, Australia, Europe, and the United States of America. All included resources appeared to have been created and/or updated within the last 10 years. Details on the number and type of resources presented in each Appendix are as follows:

Resources for parents/guardians (Appendix A): 60 resources in total from 41 organizations: 18
 Canadian, 6 Australian, 2 British, and 14 American; including website articles, information sheets, infographics, activity books, pamphlets, and videos.

- Resources for youth (Appendix B): 32 resources in total from 22 organizations: 9 Canadian, 3 Australian, 2 British, and 7 American; including website articles, downloadable information sheets, infographics, activity books, comic books, reports, presentations, and videos.
- Resources for educators (Appendix C): 48 resources in total from 35 organizations: 14 Canadian, 5 Australian, 7 British, 3 European, and 7 American; including website articles, information sheets, toolkits, program or workshop activity guides, activity books, presentations, videos, and educational materials/lesson plans.

Overall, the resources included in this scan were developed by a wide variety of government, non-profit, technology, community, education, and sexual health organizations. While most resources did not include citations and/or a reference list, each organization that developed the resource(s) were deemed reputable and/or typically use evidence-based information. Citations and reference lists were more common in the resources for educators than the resources for parents or youth.

Within the resources, information about sexting was often included in a larger discussion about internet and social media use as well as pornography (e.g., Institute for Public Policy Research, the Sex Information & Education Council of Canada). With respect to provision of information on the potential impact(s) of sexting, legal consequences (e.g., exploitation) were by far the most widely discussed, followed by emotional/psychological (e.g., shame), personal (e.g., reputation), social (e.g., bullying), and relational consequences (e.g., broken trust).

A few resources also noted potential impacts of sexting on future employment, education opportunities, and finances (e.g., Child Exploitation Online Protection, Kids Helpline, Healthy Teens Magazine, and NetzSmartz). Two resources (i.e., Australian Psychological Society, Scarleteen) noted potential developmental consequences related to sexting (e.g., how sexting can impact sexual development). Two resources (i.e., Scarleteen, Foundations – Jessie Hunt) mentioned gender-based consequences related to sexting (e.g., sexual double standards). A small portion of resources from five organizations (i.e., Australian Government, MediaSmarts, Bish United Kingdom, and California Partnership to End Domestic Violence) presented potential positive outcomes for romantic and sexual relationships (e.g., increased closeness, enhanced sexuality), but no resource presented positive impact(s) of sexting on reproductive decision-making.

Most resources appeared to take a balanced and/or neutral approach to information provision. However, some resources adopted a harm reduction (e.g., California Partnership to End Domestic Violence, Foundations – Jessie Hunt, Healthy Teens Magazine) or sex-positive approach (e.g., Bish United Kingdom), while others employed fear-based messaging (e.g., Ipsos Mori) or encouraged an abstinence-only approach. In some fear-based or abstinence-only resources, sexting was framed as a disordered or impulsive behaviour, often occurring under the influence of substances (e.g., Connect Safely), and even a behaviour that "violates God's standards and parameters for our enjoyment of His beautiful gift of sexuality" (Center for Parent/Youth Understanding).

Although some authors indicated their resources were informed by youth voices and experiences (e.g., Beyond Borders), only a small portion actually applied a youth perspective where it was clear the resource was informed by and/or created for youth (e.g., Raising Children, MediaSmarts).

Three resources offered "how-to tips" regarding sexting (i.e., Bish United Kingdom, and Kids Help Phone), and some included steps for people to take and who to contact if an image they sent went public (e.g., Cyberwise).

Resources targeting parents/guardians primarily defined sexting, explained why youth engage in sexting, presented statistics on youth sexting behaviour, and outlined the potential consequences of sexting. Many of the resources also provided tips for parents on how to talk about sexting with their children, how to report issues such as cyberbullying, and what to do if their children send or receive explicit photos. Some resources focused on youth-to-youth sexting (e.g., Canadian Paediatric Society), while others discussed the dangers and legal implications of youth-adult interactions (e.g., Children of the Street Society). The predominant message within the resources for parents/guardians is that sexting is risky, and youth must be protected and kept safe from the inherent dangers of engaging in this behaviour. To this end, one organization (Safer Schools Together) developed a Sexting Safety Agreement for parents/guardians to sign with their children.

Resources for youth largely provided information on the prevalence of sexting, motivations for sexting, and potential consequences related to sexting. Although legal consequences were most often discussed, some resources focused on other potential consequences, including emotional ones (e.g., Get the Facts). Many resources also offered tips to help youth sext more safely (e.g., Kids Help Phone). One resource outlined self-care tips for youth dealing with mental health concerns related to sexting and online communication (i.e., South West Grid for Learning Trust), while another described the best approach to taking a good picture to sext (i.e., Bish United Kingdom). In an effort to appeal to youth, a few resources adopted a comic-style for information provision (e.g., NetSmartz, Administration for Children and Families, South West Grid for Learning Trust).

For educators, several full lesson plans related to sexting were found (e.g., Growing & Developing Healthy Relationships – Government of Western Australia Department of Health). The main objectives of the lessons relate to teaching youth about the definition, prevalence, and potential consequences of sexting. However, some lessons appeared to take a harm-reduction approach to sexting by helping students understand the full spectrum of sexting behaviours and potential benefits (e.g., California Partnership to End Domestic Violence). Activity sheets/booklets for students, PowerPoint presentations, and videos are included in many of the lesson plans.

### 4. Conclusions

The findings of the current environmental scan suggest that there are a wide variety of national and international online resources on sexting designed specifically for parents/guardians, youth, and/or educators. All of these resources being online makes them incredibly accessible, and because many

of the resources are in printable formats, they can be made available to individuals without internet access. Most of the included resources were sourced from Canadian organizations and websites, but there are also many from Australian, European, and American webpages. No Saskatchewan-based resources on sexting were located through this scan.

With respect to content, most resources focused on defining sexting, presented prevalence estimates of sexting behaviours among youth, and warned of the potential consequences related to sexting. Legal consequences were predominantly discussed, particularly in relation to sharing nude/intimate images online. Discussions of the potential benefits and positive aspects related to sexting were scarce compared to the dominant focus on potential negative consequences. Although there were some examples, resources that incorporated youth perspectives and voices were less prevalent. Finally, no resource presented potential impact(s) (positive or negative) of sexting on reproductive health. There may be a need to develop a more comprehensive resource that provides a balanced and complete perspective on sexting.

With all of this in mind, there are many excellent resources available to access and/or adapt. The following are the top recommendations for each category.
